Council Comments & Staff Reports

Mayor Naughton asked the Council to consider amending the Borough's ordinance in connection with smoking on the beach. The Mayor stated that the current ordinance bans smoking on the beach and the North and South Pavilion areas only and asked the Council to consider expanding the ban to include the entire length of the boardwalk noting that she would be very supportive of such a ban. The Mayor stated that several beach towns have adopted similar ordinances. Mrs. Venables voiced support for such an amendment. Mr. Judge voiced his support his well. Mr. Erbe asked what the potential alternative would be for people. Mayor Naughton stated that it's not unlike the trend of banning smoking in public places and within 25 feet of public building entrances. Mayor Naughton also noted that there are no receptacles on the boardwalk for cigarette butts and therefore the butts are being tossed on the sand and on the westerly dunes. Mr. Erbe stated that although he too supports the idea of no smoking on the beach and boardwalk, he's empathetic to smokers and would like to see some type of viable alternative. Mr. Dempsey spoke to the issue of enforcement noting that such an ordinance may force the smoking to the entrance areas of the pavilions and the boardwalks. Mrs. Venables suggested designating an area for smokers that sits between the curb and the pavilion and voiced that the priority accommodation should be for those who do not want to breathe second hand smoke. Mr. Dempsey asked for clarification that the ban would be on the boardwalk as well as the walkways and if someone wants to smoke they must smoke on Ocean Avenue. The Mayor confirmed suggesting that the ordinance be introduced and the issue be further discussed.

Mr. Judge reported that, in response to Ms. Dubac's request, he met with Trish Hansen, the President of the H.W. Mountz Board of Education, and Ms. Hansen expressed an interest by the Board in considering a set of restrictions in connection with the basketball court usage. Mr. Judge stated that Ms. Hansen will be meeting with their policy committee.

Mr. Avakian referenced Mr. Dempsey's comments in connection with the sluice gate noting that there will be two (2) meetings with Fish and Wildlife in the coming weeks regarding the bypass pipe.

Mr. Avakian continued that he looks forward to working on the road program with the council and is confident they can develop a viable long-term program. Mayor Naughton inquired about the DOT grant. Mr. Avakian expressed disappointment stating that the office is no longer local but based in Trenton and as a result they're finding it more difficult to get information. Mr. Avakian further reported that no grants have been announced.

Mr. Avakian reported on the New Jersey Infrastructure Trust item on the Consent Agenda noting that as a result of the recent in depth studies done at Wreck Pond, they will be moving forward with some immediate repairs as well as a list of other recommendations that will be quite costly. Fortunately, the DEP awarded \$525,000 to the Borough to implement these repairs, stated Mr. Avakian. A completed plan has been submitted which will be reviewed by the DEP prior to going out to bid and sometime post-summer the work will begin.

Mr. Colao reported that he has one matter for Closed Session.

Mr. Dempsey reported that the gates for the sluice gate project will arrive approximately April 28, 2014 and the work will begin roughly the first week of May and will last anywhere from five (5) to seven (7) days.

In connection with the Warren Avenue COAH project, Mr. Dempsey reported that the foundation is in and utilities are being installed. Framing should take place soon stated Mr. Dempsey and thus far there have been no concerns voiced by residents. Mayor Naughton asked Mr. Dempsey to speak to the application process. Mr. Dempsey stated that the Affordable Housing Alliance is the administrative agent for Spring Lake and all applications will be submitted to them for review for compliance. Once reviewed, accepted applications will go into a lottery for selection, Mr. Dempsey stated, and the selection should take place in the next couple of months. The Borough has no involvement in the selection process, stated Mr. Dempsey.

Regarding the cherry tree projected that Mrs. Venables spoke of, several bids came in and Burke Environmental was the lowest bidder, reported Mr. Dempsey. The trees should be planted the third week of April. As for the Third Avenue tree project, seven (7) trees have been planted and the Borough has allowed them to extend their working hours in an effort to expedite the project. Mr. Dempsey reported that the contractor has been very considerate and has been working well with local merchants and visitors.

Mr. Judge inquired as to whether there have been bids submitted in connection with the three (3) lots being sold by the Borough. Mr. Colao stated that there are certain advertising requirements that need to be done prior to accepting bids and that he expects bids to be entertained in early May. Mr. Jordan inquired about the status of changing the street name. Mr. Colao stated that the issue of the street name is still pending.

Mr. Dempsey continued reporting that the concession bids for Pier Beach and the North and South End Pavilions have been received and awarded reporting that Josephine Ferraro was awarded the South End; Scott Cullen, Fork in the Road, was awarded Pier Beach; and Nick Bruno of Whispers was awarded the North End. Mr. Dempsey reported that the highest bid amounts were greater than last year. 24867
