Eleanor Twomey, Vroom Avenue asked for an explanation of Resolution R-12-072 Tax Reimbursement Certification Resolution. Borough Clerk, Jane Gillespie explained that it's a reclamation tax paid which requires a request for reimbursement.

Council Comments & Staff Reports

Mayor Naughton reported on the following:

- JCP&L Meeting The Mayor and Borough Administrator Dempsey met with an executive of First Energy/JCP&L. At the meeting they discussed their concerns about the lack of response the Borough has received specific to on-going problems such as lights not being replaced in a timely basis, light poles missing on the boardwalk, etc. and our concern about the lights being replaced with yellow bulbs versus white. There is not a tariff on white bulbs, therefore, as lights go out they will be replaced with yellow bulbs. The option for the Borough would be to take control of the light replacement effort, which would be a rather expensive undertaking or to work with them to exhaust the dwindling supply of white lights. Mercury lights are no longer made, and the yellow light is a more energy efficient light. So, for lights owned by JCP&L, when one goes out, they will use their supply of white lights to replace it until the white light supply is depleted at which time they will begin using yellow lights. The Mayor further reported that it should take seven to ten days to get a light replaced. As for the pole, it has been replaced. The Mayor felt that the meeting was worthwhile and that the representative left with a promise to deliver better service.
- <u>Warren Avenue COAH Project</u> The Mayor reported that the revised plans for the four-family home should be available to the COAH Committee us by this Friday and if we agree on the plans we can move forward on getting the project underway.
- <u>Sedimentation Removal Project</u> The Mayor reported that she, Council Member Venables, Mr. Avakian and Mr. Dempsey have a meeting with the County on Friday in connection with the county's willingness to remove sedimentation east of the First Avenue bridge which is an essential step in order for us to put pumps in place. Given that the sand content came back at a 90% level, the County may use the removed sedimentation as land-fill.

Mrs. Venables reported that the Department of Transportation has granted the Borough \$200,000 for road improvements which will be used on Third Avenue to improve sidewalks, curbs and crosswalks. In addition, we hope to use some of the grant money for repaving in other areas. Also, Mrs. Venables reported that the Spring Lake Garden Club is hosting an Arbor Day ceremony on April 25, 2012. All are welcome to participate.

Mr. Jordan gave an update on the beach/pool badge and locker sales reporting that the website is up and running.

Mrs. Reilly reported that on April 21, 2012 at 9:00 am the Borough will have computers and personnel available to assist residents in the purchasing process. Mrs. Reilly noted that additional mailings will also be going out to residents that have not yet registered an email address notifying them of the badge/locker sales process. Mrs. Reilly reiterated that non-

residents may be sponsored by a resident to purchase lockers/badges after May 12. Mrs. Reilly also shared information regarding identification required to pick-up badges.

Mr. Judge, in connection with the North End Pavilion, reported that the Committee hopes to receive revised plans from the Architect this week with the hope of going out to bid no later than next week. Also, Mr. Judge reported that he met with neighbors of Mountz School to address their concerns regarding the proposed playground and basketball court and shared their concerns with the committee. Mr. Judge reported that no decisions have been made and that the committee will be meeting with the neighbors again prior to any final decisions.

Borough Engineer's Report

Mr. Avakian reported on the paving of Newark and Adrian Avenues noting that a water service test fractured the pavement but it has since been repaired. Mr. Avakian also reported that the curb cut on Adrian will be replaced. In connection with Marucci Park, Mr. Avakian reported that an underdrain was installed this week. Finally, Mr. Avakian reported that in the past 5 years, the Borough has paved seven (7) roads and has received \$1.15 million in grants which represents more than half of the total value of the construction costs. Mr. Avakian reported that the Morris Avenue grant would come from a different grant fund.

- 1. The total number of catamarans shall not exceed 20 without further approval of the Borough.
- 2. The fee payable to the Borough's Beach utility for each boat shall be \$150 for each boat for the 2012 season. Each Catamaran must display a permit decal to be provided by the Borough upon receipt of the fee.
- 3. All individuals wishing to utilize boats shall be required to have valid beach badges, whether seasonal, half season, monthly or daily.
- 4. Each club member/catamaran owner shall be required to execute a Release, Indemnification and Hold Harmless Agreement in favor of the Borough and its officers and employees for any claims arising out of the use or placement of the boats on the Spring Lake beach.
- 5. Each boat owner shall carry and provide proof of liability and personal injury insurance covering the catamarans in the amount of \$100,000 per person and \$300,000 per occurrence.
- 6. The Borough shall have no liability for the safekeeping or security of the boats on the beach.
- 7. The boats shall only be kept and stored in the approved location(s) designated by the Borough.
- 8. The agreement shall be immediately terminable at the option of the Borough if the same is deemed to be in the interest of the public health, safety and welfare.
- 9. All boats will be removed from the Spring Lake beach at the end of the beach season, no later than the date determined by the Borough, which date will be communicated to the Club to provide at least two weeks' notice.
