#### **Public Comments**

Eleanor Twomey, 108 Vroom Avenue, questioned by the Ordinance amendment discussed at the last meeting was not on the Agenda. She was advised that it was not prepared and will be ready for the next meeting.

Lyle Marlowe, 110 Pennsylvania Avenue, expressed his concerns with the Ordinance on Flood Prevention which is scheduled for a public hearing this evening.

Marie Reed, 11 Passaic Avenue, voiced her concerned with the beach access decisions and felt that additional traffic will be on Passaic Avenue because of it. She is advised that as many accesses as practical were going to be opened for the 2013 season and that additional access will be made for the 2014 season. Budget constraints were also a factor in this decision.

Barbara Fleming, 7 Passaic Avenue, also voiced her concerns with increased traffic on Passaic Avenue as a result of the changes made to beach access.

#### **Council Comments & Staff Reports**

Mayor Naughton welcomed, Bryan Dempsey, Borough Administrator, back to work after his recent absence.

Mr. Avakian explained that in 2009 FEMA updated its FIRM maps following that, Spring Lake adopted its flood damage prevention Ordinance. In December, 2012 FEMA produced for review the ABFE maps. After a lot of public discussion, Governor Christie recommended these maps. He then reviewed the changes which would effect the Borough. He explained that construction methods are identified and will be enforced by the Construction Official.

Mr. Lyle Marlow, 110 Pennsylvania referred to the email regarding proposed Ordinance 2013-002. His email questions the impact the Ordinance would have on him and he explained that height decisions should be made by the property owner as building requirements will also be used to flood define flood insurance costs.

Mr. Fay questioned staffing at the Bath & Tennis beach? Mr. Judge advised that there would be a meeting held with their representatives to discuss this.

Mrs. Venables reported on the Third Avenue Project which will be done in phases. The project has been designed by Melissa Ix and is being done by the Shade Tree Committee in conjunction with the B.I.D. Everyone has worked really hard on this project and she is excited to see it get underway. They have also assisted with the tree planting around the Mountz School.

Mr. Judge reported that on March 3rd a meeting was held with representatives of the First Aid and Fire Companies with respect to volunteer beach badges. Those present agreed on behalf of their organization to tie the award to LOSAP recipients and that the Borough has the right to issue one badge and for the second badge an identification card could be issued. The \$175.00 non-resident fee would be waived. There is a Resolution on tonight's Agenda approving this and outlines what was discussed and agreed to.
