### **Workshop Discussion**

Energy Market Exchange (EMEX) – John Smith, Director of National Accounts, presented a pilot program for local units to procure electricity using an electronic process through a reverse auction which is a five minute online auction. He added that his company has helped over one hundred and fifty government agencies. He explained that the auction contracts can be for one year, eighteen months, or two year fixed rates. He added that energy prices are currently down, making it an ideal time to purchase a fixed contract from a third party supplier. Mr. Smith continued by added that EMEX is paid by commission by the supplier chosen, even though an auction is run, the purchaser does not have to accept the bid.

Mr. Judge asked if townships have encountered any issues with using the auction and also third party providers. Mr. Smith answered billing, sometimes if the town is sixty or ninety days late, PSEG and JCPL will bump the town off and the town would receive dual billing and possible late fees.

Mayor Naughton then asked if there would be an advantage for municipalities to bid together. Mr. Smith answered yes. Mayor Naughton opined that one downside would be if the town accepted a bid and then energy prices continue to drop. Mr. Smith agreed and added that JCPL is on a tariff rate; the rate does not drop that much. He added that rates are based off of a three-year rolling average, new tariff rates will be announced in June and he predicts the rates will remain the same or will be slightly increased. Mayor Naughton suggested talking to neighboring towns to see if they would be interested in bidding together to cut costs. Mr. Smith added that if another town or authority had larger meters this would help bring the cost down.

Mr. Drasheff thinks it would be a good idea for other municipalities to join together however, this may take a few months to get everyone on board. He added that it is a good idea to at least do the auction and possible one year agreement.

Mr. Smith explained that the auction can be set up on a day that there is a council meeting so that if the Borough decides to enter into the agreement it can be done at the meeting that same evening.
