Chief Dawson congratulated Ed. He stated that it was fourteen and half years ago that he stood in this same room. He acknowledged that there were several Chiefs from the surrounding towns present this evening, members from the Monmouth County Staff. He thanked the Mayor and Borough Council for moving the promotion along.

Presentation - Chief Robert J. Dawson - Mayor Naughton noted that Monday is the Chief's last day in the Borough before he heads off to the Monmouth County Sheriff's Office to take on his new responsibilities. She stated that she grew up with Bob and shares a love for this small town, shore life and tight knit community that develops from that type of town. remembered when he was appointed Chief in 1996 and at the time as a resident thought that he would make a good Chief. It wasn't until she started serving on the Governing Body that she realized just what a strong leader had become. He started as a dispatcher in 1981 and Special Officer in 1982. He worked briefly for the Spring Lake Heights Police Department before becoming a full-time officer here in Spring Lake in 1985. He rose up to the rank of Detective/Sergeant and Captain before he was named Chief by Mayor Tom Byrne in 1996. From the beginning Bob worked hard to earn the respect of his men and of the residents. He made it his business to develop relationships with the residents, the Borough Staff and the business community here in Spring Lake. He empowered his team to do the same. His first priority has always been Public Safety but he took his role beyond that and put an approachable face on the Spring Lake Police Department, a quality so important in a community. intelligence, his sense of humor and his innate sense of fairness served him very well in his daily round of work with the public and he handled a number of extremely difficult and high profile issues with grace and sensitivity. Bob, in her opinion, is an outstanding example of what the Chief of a small community ought to be. He never lost sight of the fact that he served the residents of Spring Lake and in return we gave him our lasting respect and our loyalty. Selfishly she had hoped that Bob would stay as Chief for many more years. He has been a trusting confidant and a good friend and perhaps will feel his absence more keenly then she will. She is proud that the Sheriff's Office reached into our ranks to select their Under Sheriff and we wish Bob all of the best in his new position.

Mrs. Reilly presented Chief Dawson with a picture of the Gazebo on the beach.

Chief Dawson thanked the Mayor and Council for the gift.

Mrs. Venables wished Chief Dawson the best of luck and stated that he has been an outstanding Chief. Fortunately Ed has been working with you for all of these years and we have full confidence in Ed that he will serve us well but wanted to wish him the best.

Mr. Fay congratulated Bob and wished him good luck at the County. He also welcomed Ed aboard and he is looking forward to working with him.

Mr. Drasheff stated that in the short time he has known Bob, he has been a great Chief. He exercised the key element that makes a great leader. He stated that he has had great judgment and that is what made him a great Chief. He felt that this is what the Committee also saw in Ed coming aboard, a man with good judgment.

Mrs. Reilly stated that she was pleased to be on the selection committee when he was appointed Chief and to be serving now. She is sorry to see him go. She welcomed Ed aboard

and is sure he will do as well as Bob did and make the Council proud. She thanked him for accepting the appointment.

Chief Dawson also recognized Assemblyman David Rible who was present.

Tom Byrne congratulated Bob and commented on one of the high profile cases he was involved with that turned out well.

Eleanor Twomey, Vroom Avenue stated she was speechless.

Public Comments

Dr. Patrick O'Connor questioned why there is no ice skating on the lake. Mrs. Reilly stated that she inquired about this yesterday. She spoke with the Chief and he advised her that it has to be seven inches thick before skating can be allowed. Chief Dawson explained that the Department follows the guidelines as provided by our insurance company. There is an opening in the ice by the outfall pipe which would be irresponsible for us to open it up. We are close to where we need to be but are not there. Dr. O'Connor stated that there would never be 100% coverage. He asked why cones couldn't be placed in that area. Chief Dawson responded that the Borough would be allowing an attractive nuisance. He stated that people have walked on it but that is one or two people not a hundred. Mayor Naughton stated that we will look and see if there is an area that can be coned off. Chief Dawson advised he would look into roping off an area from the fire pit to the bridge if there is a mechanism to rope it off because it is not supervised. Dr. O'Connor suggested having volunteers supervise the area. Borough Attorney Colao stated that the Borough must file the guidelines provided from our insurance carrier and not deviate from those even though it may seem logical or make sense. He added that once we go outside of their guidelines we are exposed. It would be an attractive nuisance and an unsafe environment. Mrs. Venables stated that it has been while since we have been able to skate there.

Harry Zarb, 2205 Ocean Avenue questioned if Black Creek is frozen enough to skate on? Chief Dawson stated yes and stated that Wreck Pond is shallow and perhaps that can be tested.

Harry Zarb, Third Avenue mentioned that after the big snow a lot of the fire hydrants were covered over. He suggested that the hydrants be marked somehow. Mayor Naughton stated that it is a good point and was brought up by a couple of other people. After the last snow, the first thing they did was dig out the fire hydrants. There are markings on most of them but she is not sure they would have been seen through some of the drifts of that storm. Mr. Dempsey worked with Frank Phillips, DPW Superintendent after those concerns were raised to come up with a procedure to dig them out first. Mr. Dempsey stated that there are more markers that have to be put out.

Mr. Zarb then commented on the process for getting the street lights fixed. He felt that the couple of weeks ends up taking months to get them fixed. Mr. Dempsey to address the issue with JCP&L Company.

Mrs. Venables stated that the replacement of Steve Dombrowski was appointed this evening. She just wanted to acknowledge and recognize to the audience here that Steve has really served the Borough very well. He has been here over thirty years and has a passion what he does. He has been in charge of planting all of our flower for all of these years. He really took charge of revamping that area we worked on along Fifth Avenue that was a dirt strip. He and Don Brahn Jr. transformed that into a park. He has done a magnificent job for a very long time for the Borough and is retiring. She just wanted to acknowledge his service to the Borough. Don Brahn Jr. will be stepping in and taking charge of the greenhouse and being responsible for the shade trees that Steve has worked so closely with the Shade Tree Committee on planting and taking care of them. Don has caught that contagious passion that Steve has for planting and doing such a good job. Steve went through a horticulture program up at Rutgers and is just so knowledgeable and it will be a big loss to the Borough although she knows Don will do a great job too. She has been involved in the Shade Tree Committee a long time and she knows how hard he worked and the pride he took in the job he did and he ought to be very proud of the work he has done for the Borough. Mayor Naughton stated that she would like to add her thanks and appreciation to Steve too. She also was a member of the Shade Tree Committee and he is singularly dedicated and he is leaving a pretty big green footprint here in town as his legacy and we are lucky to have that. We are fortunate that Frank Phillips believes in it as well and allowed him to work in that capacity.

Mrs. Reilly noted that he was also very helpful when they were building the rain gardens.
